






Location Plan




Shaded 1 hectare square in centre is expanded on Mining Activity Plan over page

SCOPE

This mining search is an assessment of official data supplied by The Coal Authority to determine the risk of coal mining settlement and/or subsidence. It is undertaken on behalf of the client, their mortgagees and legal advisers.

It is based on official data supplied by The Coal Authority at the time of production. This assessment is only relevant to the property delineated on the supplied location plan.

PAST UNDERGROUND COAL MINING

The property is in the likely zone of influence from workings in 1 seam of coal at 100 metres depth, last worked in 1925.

Any ground movement from these workings should have stopped by now.

PRESENT UNDERGROUND COAL MINING

The property is not within a surface area that could be affected by present underground mining.

FUTURE UNDERGROUND COAL MINING

The property is not in an area where the Coal Authority has plans to grant a licence to remove coal using underground methods.

The property is not in an area where a licence has been granted to remove or otherwise work coal using underground methods.

The property is not in an area likely to be affected from any planned future underground coal mining.

However, reserves of coal exist in the local area which could be worked at some time in the future.

No notices have been given, under section 46 of the Coal Mining Subsidence Act 1991, stating that the land is at risk of subsidence.

MINE ENTRIES

There are no known coal mine entries within, or within 20 metres of, the boundary of the property.

COAL MINING GEOLOGY

Mining Searches UK are not aware of any damage due to geological faults or other lines of weakness that have been affected by coal mining.

PAST OPENCAST COAL MINING

The property is not within the boundary of an opencast site from which coal has been removed by opencast methods

PRESENT OPENCAST COAL MINING

The property does not lie within 200 metres of the boundary of an opencast site from which coal is being removed by opencast methods.

FUTURE OPENCAST MINING

There are no licence requests outstanding to remove coal by opencast methods within 800 metres of the boundary. The property is not within 800 metres of the boundary of an opencast site for which a licence to remove coal by opencast methods has been granted.

COAL MINING SUBSIDENCE

The Coal Authority has not received a damage notice or claim for the subject property, or any property within 50 metres, since 31st October 1994.

There is no current Stop Notice delaying the start of remedial works or repairs to the property.

The Coal Authority is not aware of any request having been made to carry out preventive works before coal is worked under section 33 of the Coal Mining Subsidence Act 1991.

MINE GAS

Mining Searches UK has no record of a mine gas emission requiring action.

HAZARD RELATED TO COAL MINING

The property has not been subject to remedial works, by or on behalf of the Authority, under its Emergency Surface Hazard Call Out procedures.
